## ADDITIONAL INFORMATION

### Parcel delivery

Delivery to a business or private address between 8:00 and 18:00, usually on the next working day.

### Delivery in selected locations

The service is available for parcel shipments only in selected cities and locations (list of locations on the PPL website).

### Communication with recipient

Communication includes email and SMS communication with information about delivery time within the range of 2 hours.

### Delivery to PPL pickup points (Parcelshop and Parcelbox)

Package delivery to a pickup point where packages can be picked up during shop opening hours or at any time at the Parcelbox. Maximum storage time for parcel is 7 days in Parcelshop, 3 days in Parcelbox and 2 days in Third Party Box.

### Cash on delivery from the recipient

Cash on delivery up to CZK 100,000. Possibility of payment in cash or by credit card. Maximum cash payment from one payer in one day for all deliveries is CZK 270 000.

### Parcel tracking

An up-to-date overview of parcel delivery is available on the website [www.ppl.cz](http://www.ppl.cz) and in the mobile app mojePPL.

### Electronic confirmation of delivery

It allows you to obtain details with a digitally recorded signature of the recipient.

### Transportation order

Possibility of ordering a collection at the address of your choice within the Czech Republic, which varies from the regular collection address. Delivery to any address in the Czech Republic.

### Invoice claims

The Customer is entitled to claim the information on the invoice issued by the freight forwarder for the shipment within 2 months from the date of delivery of the invoice.
