



Solutions for atypical parcels

What is an atypical parcel?

An atypical parcel is one which is difficult to handle. In particular due to the fact that it exceeds the permitted dimensions or weight, one which does not have a regular shape, is inadequately packed, or cannot be sorted on an automatic line.

CLASSIFICATION OF PARCELS



Standard parcela

- maximum parcel dimensions $120 \times 60 \times 60$ cm
- \bullet sum of circumference and length at most 360 cm
- maximum weight 31.5 kg
- cardboard box in the shape of a cube or a block (can be protected with foil)



Atypical parcel

- one side of the parcel is longer than the maximum permitted dimension
- maximum length of one side 200 cm
- inadequately packed parcels
- parcels with a distinctly irregular shape
- car and motorcycle tyres



PPL Parcel Max+ parcels submitted for forwarding on pallets

- length of longest side more than 200 cm
- sum of circumference and length more than 360 cm
- weight more than 50 kg
- car and motorcycle tyres larger than the permitted size and quantity (see atypical types of parcels

EXCEPTIONS



Parcels which are not classified as atypical parcels

- envelopes and parcels in a bag (max. 60 x 40 x 36 cm, 3kg)
- compact bundle of at most two regular shaped parcels, regardless of their different sizes, with a solid base

Packing parcels

- proper packing will better protect your parcel against damage (for more details, see www.ppl.cz)
- in addition to this, you enable us faster and safer handling and avoid the risk of surcharges for atypical parcels





Solutions for atypical parcels

TYPES OF ATYPICAL PARCELS



Oversized parcels

- one side of the parcel is longer than the maximum permitted length
- maximum length of longest side 200 cm



Tyres

- unwrapped tyres for passenger cars or motorcycles
- max. number of tyres without wheel in one parcel 2 tyres max. 18"
- tyres with wheels 1 set max. 18"



Other unsortable

- oparcels which cannot be sorted on an automatic sorting line
- this mainly concerns irregularly shaped parcels, parcels with protruding parts, etc.
- this category also includes parcels in the shape of a sack

Surcharge for atypical parcels

Due to the increased cost of handling these parcels, a surcharge is applied to the following types of parcels:

• atypical parcel surcharge CZK 318

PPL Parcel Max+ parcels submitted for forwarding on pallets

Parcels which match the parameters below are passed on to DHL Freight for forwarding on pallets and the price of forwarding is based on the PPL Parcel Max+ price list.



Forwarding on pallets

- length of longest side of parcel more than 200 cm
- sum of circumference and length of parcel more than 360 cm
- unauthorised size or number of tyres
